
Details of Revised Transmission Capacity allocation of distribution licensees for the month of May 2012

The Transmission capacity is being revised due to an inadvertent error in calculation of Capacity Allocation of Chhattisgarh Power through JPL which was wrongly booked to BYPL in Place of BRPL .
